## Minutes of the Sustainable Cottenham Annual General Meeting Held via Zoom

## at 7.30pm Tuesday 9 March 2021

- 1. <u>Chair's Report:</u> Chris Ward opened the meeting, welcoming the attendees to the first Annual General Meeting of Sustainable Cottenham. Her report (already disseminated with the meeting Agenda) covered the origins of Sustainable Cottenham, leading to its earlier status as an 'unincorporated association', and current status as a Charitable Incorporated Organisation (CIO) since 25 March 2020 with 20 active members, 297 'followers', and other helpers. She mentioned the current projects, including 'EcoEats', the litter pick, Cottenham Connected and Plastic Free Cottenham, looking forward to restarting these efforts in the community, post-pandemic.
- Treasurer's Report: Catherine Burch gave details of the financial situation of Sustainable Cottenham, (also previously disseminated with the meeting Agenda). She highlighted the sources of funds, the regular expenditure on insurance, and showed those sums allocated to specific projects. In addition the accounts of the previous 'unincorporated association' and the current CIO were discussed.

Sustainable Cottenham's cash balance as at 31 December 2020 was £3,855.50, of which £835.32 is not committed to projects.

  - b. The natural environment of the village, and whether property developers still have contributions to make.
  - c. The possibility of sharing arrangements for herb and other plants.
